

Three Overarching Goals

"[To] develop, expand, connect, and support sustainable, high-functioning aging and disability CCHs and their network of social care program and service providers (Hub Network) through infrastructure funding, technical assistance, and multi-level capacity building efforts that promote whole-person care through the alignment of health, public health, and social care systems."





Three Overarching Goals

"[T]o support [CCH] contracting efforts with relevant health care and public health organizations (e.g., accountable care organizations, health plans, health systems, state Medicaid agencies, Medicare, employers, and more) for coordinated access to and delivery of social care programs and services (including support for hospital-to-home care transition programs) that assess and/or address health-related social needs (HRSNs) and improve health equity and inclusion for individuals, families, and/or caregivers."





Three Overarching Goals Continued

"[To] enhance state No Wrong Door (NWD) access systems and coordinate with local and/or state public health departments."





What is a CCH?

"[A] Community Care Hub (CCH) ... serves as a community-focused, regional, statewide, or multi-state umbrella organization that coordinates administrative services and supports for a network of social care providers ... providing social care programs and services to address health-related social needs (HRSNs) under funding arrangements with health care organizations, public health departments, Medicare, Medicaid, etc. A CCH may also offer its programs and services directly to consumers through a variety of payment arrangements and may hold contracts with government agencies to coordinate administration of programs and services across a region or state."





What is the Purpose of a CCH?

"[A] CCH centralizes and scales administrative functions and operational infrastructure to enhance efficiencies, standardization, compliance, performance, and quality on behalf of its Hub Network of social care providers."





What is a Hub Network?

An organized network of experienced social care providers with the capacity and willingness (and formal agreements) to provide a defined set of social care products, programs, or services to health care organizations or other funders (including government agencies, foundations, etc.) through a unified contracting system organized by the CCH.





What Org Types are in Hub Networks?

- Area Agencies on Aging (AAAs)
- Centers for Independent Living (CILs)
- Food Pantries
- Transportation Providers
- Faith-based agencies
- Public Health Departments
- Other CBOs





Who Can Apply?

"Domestic public or private non-profit entities including state and local governments, Indian tribal governments and organizations (American Indian/Alaskan Native/Native American), existing CCHs, faith-based organizations, community-based organizations, and institutions of higher education."

Examples: AAAs, CILs, other nonprofit agencies and CBOs that desire to be a regional, statewide, or multi-state hub for this work.





CT Evaluation Opportunity





What is the CT Evaluation?

A small group of COE Grantees with experience providing hospitalto-home care transitions will be selected to participate in a sitespecific evaluation to assess the extent to which CCHs affect client-level health and social outcomes through hospital-to-home care transitions programs.





What CT Programs are Eligible?

CT Programs must include the following evaluation features:

- HRSN screening/assessment, information, and referral/linkage
- Transition-related case management/service coordination and coaching
- Follow-up post-discharge

Additional details will be provided to COE Grantees selected to participate in the CT Evaluation after the COE Grantee awards are announced.

COE Grant Funding Uses: Examples

- Expand CCHs into geographic areas without CCH capacity and to reach underserved populations
- Improve CCH capabilities
 - Address staffing, leadership, governance needs
 - Perform financial modeling
- Increase CCH capacity
 - Support workforce develop needs across Hub Network CBOs
- Support CCH infrastructure costs
 - Address information technology (IT) infrastructure needs
- Assess CCH business requirements
 - Enhance Quality Assurance and Compliance programs

Form Example: Text Response

Project Abstract

Provide an abstract with a brief description of your CCH's proposed project. It should address the work to be performed and contain clear, measurable project goal(s), objectives, and anticipated/desired outcomes.

Please include information on the following proposed project goals:

- · specific services to be delivered,
- · Infrastructure to be secured,
- skills and expertise to be developed, and/or
- · capacity to be built or enhanced, if funded.

A non-exclusive list of ways funds can be used is provided on pages 10-12 of the RFP.

You should ensure the project abstract communicates a clear sense of the work your CCH intends to perform (if funded) and anticipated outcomes of that work. Outcomes should be clear and measurable and, where applicable, include expected outcomes for the CCH, its network CBOs, your contracted clients (e.g., health care organizations), and the individuals you serve.

Form Example: File Uploads

Hub Network participating CBOs

Include letters of commitment/support from all participating CBOs in your Hub Network.

Ensure that the network is sufficiently broad and aligned with the programs and services your CCH intends to offer.
